- Showcase booths must be manned during operating hours.
- The application must provide in detail the items you are selling/advertising.
ALL items being sold, displayed, and promoted should be family friendly.
- Please complete the attached application and return it with full payment by **January 31, 2025**.
- **All payments are non-refundable.**

Showcase Booth Specifics:

Inside Booth 10'(w) x 10'(d) inside the Gladstone Community Center with other vendors

- 8 ft table and/or two chairs provided **only if needed and requested** – mark **YES** on application to request.
- Electricity is available at an additional cost, (\$20 per booth) and is **non-refundable**.

Specifics for Set-Up on Saturday, March 1st from 8:30am to 10am

Please Park on the 3rd Tier, Auxiliary Lot, or across the street at the Gladstone Office Building once unloaded.

- **Before** unloading please CHECK-IN with the Northland Business Showcase staff.
- **ALL** vendors must be set-up and have their vehicles off the front parking spaces and streets by 10AM Saturday.

During the Event:

- Vendors are permitted to market their product and/or service **ONLY** within the confines of their booth space.
- Use of audiovisual equipment is permitted, provided the sound is not over a “conversational” level. Sounds must be respectful of the surrounding vendor booths.

Specifics for Tear-Down:

Vendors must tear down immediately following the 4PM closing. Tear down **MUST** be complete before 6PM!
